2. Events

State Conference

Focused on regional content and designed for senior practitioners, the 2023 Vic/Tas Division Conference was held on 9 May at Zinc in Melbourne. 121 delegates attended the full-day conference, and 244 guests joined the networking opportunities at the dinner.

We are returning to Zinc, Melbourne for our 2024 Vic/Tas Division Conference & Dinner, which will be held on Thursday,10 October.

Small Practice Conference

Held on 4-6 October in Queenstown, New Zealand. The two-day conference exclusive to ARITA Professional and Associate members is focused on relevant, day-to-day issues for small practices. We had 82 delegates attend the conference and 100 guests attend the networking dinner.

In 2024 the Small Practice Conference will be held on 12-14 June on Queensland's Hamilton Island.

National Conference

Held on 31 July to 2 August on the Gold Coast, our National Conference sold out during the early bird period. The two-day conference attracted 251 delegates and featured wellrespected experts and thought leaders giving presentations on a range of topical issues. It also included unique networking opportunities such as group activities (new in 2023), a Welcome Reception, and the Conference Dinner, with almost 250 guests in attendance.

In 2024, we will celebrate the 30th Anniversary of the National Conference with a new event format – over three days. The conference be held on the Gold Coast, Queensland, on 10-12 April.

Expert Series Seminars

Curated with the mid to senior practitioner in mind, the 2023 online Expert Series attracted close to 600 attendees nationally across four headline topics: Bankruptcy, Insolvency, Restructuring & Turnaround and Small Practice.

In 2024 ARITA will spread out the online Expert Series Seminars with two seminars in July-August and two in November.

Forums

Delivered by subject matter experts, the forums are highly regarded for the insight the presenters provide on important emerging issues and for networking opportunities.

In 2023 the Division ran five forums attracting over 210 attendees. A special thanks to:

The ARITA National office delivered six forums online and attracted 970 attendees nationally. These Forums were offered free of charge for ARITA Members.

Young Professionals (YP) Events

The Young Professionals Committee has a primary focus to support the development needs of new entrants to the profession and help younger members progress in their restructuring, insolvency and turnaround careers.

In 2023 the YP Committee organised two seminars and three networking events with over 300 attendees in total. A special thanks to:

We look forward to having more informative and memorable YP events in 2024.

3. Education

Education of members will always be one of the top priorities for ARITA and the Vic/Tas Division.

Introduction to Insolvency Program (IIP)

Developed and presented in a live interactive environment facilitated by trainers with extensive hands-on experience in insolvency, ARITA's Introduction to Insolvency Program has provided the most reliable and accurate education to new entrants in the profession since 2005.

In 2023, an IIP course was offered in-person or online at least every eight weeks, providing firms with timely training for their junior staff. The course attracted a total of

64 attendees from the Division, spread across five online and three face-to-face courses in Melbourne.

On-demand courses

ARITA's on-demand training offers convenience, flexibility, and cost-effectiveness, making it a valuable option for individuals seeking to enhance their skills or expand their knowledge base.

- Professional Standards courses Independence and Remuneration are free of charge for ARITA Members.
- Essential Skills series: There are currently 23 courses available, with more released every month.
